The application does not entitle the applicant to receive a Comdata account. If the applicant has made an application for business credit which is denied, the applicant has the right to a written statement of the specific reasons for the denial. We will send you a written statement of reasons for the denial within 30 days of receiving your request for the statement. If applicant is a sole proprietorship or partnership and we utilized a consumer report, upon your request, we will tell you whether we obtained a consumer or commercial report (credit report) and the name and address of any consumer-reporting agency that provided such reports.

#### Comdata Fleet Card Agreement

This Comdata Fleet Card Agreement ("Agreement") is an agreement between the business ("Customer" or "you" or "your") identified in the Credit Application (defined below) and Comdata Inc. and its subsidiaries ("Comdata" or "we" or "our" or "us"), and governs Customer's access to and use of the Account(s) (defined below) and the Comdata products and services described provided for in this Agreement and any

Schedules attached hereto ("Program").

COMDATA IS MAKING THE ACCOUNT AND PROGRAM AVAILABLE ON THE TERMS SET FORTH IN THIS AGREEMENT AND ON THE CONDITION THAT CUSTOMER ACCEPTS AND COMPLIES WITH SUCH TERMS. BY CLICKING "SUBMIT APPLICATION' IN THE FLEET CARDONLINE APPLICATION, CUSTOMER HEREBY SIGNS AND ACCEPTS THE TERMS OF THE AGREEMENT. IF CUSTOMER DOES NOT AGREE TO THE TERMS OF THIS AGREEMENT, NOT CLICK "SUBMIT APPLICATION'.

#### 1.Account & Cards

- (a) Nature of Account and Card Use. Comdata will provide Customer with one or more accounts ("Account(s)") through the use of which Customer may access certain card networks ("Networks"), and the financial information and other Program products and services made available by Comdata under this Agreement. In connection with the Account, Comdata shall provide cards ("Cards") issued by Comdata. Comdata may limit the amount of Express Comcheks that Customer can issue to an amount less than the available credit for an Account. Certain products, including without limitation cash products such as Comchek, are available only to customers that meet eligibility requirements.
- (b) Credit Limit Security. Comdata may establish a credit limit for the Account, which is subject to review and adjustment by Comdata in its sole discretion. Customer will provide Comdata with all reasonably requested financial information. Customer consents to Comdata's conducting credit investigations and exchanging payment information with credit agencies and credit grantors under Comdata's credit policy. Customer has submitted a credit application ("Credit Application") as part of Customer's application for the Account and Program. Customer acknowledges that Comdata's establishment of the Account is subject to Comdata's review and approval of Customer's Credit Application. Customer represents, warrants, and covenants that all information stated in the Credit Application is truthful and accurate. From time to time Comdata may request Customer to provide security for the performance when due of Customer's obligations hereunder. Customer understands and agrees that it is under no obligation to provide Comdata with such security, but the refusal to provide security when requested may result in adverse credit determinations by Comdata. Any security provided shall be in the amount and form as required by Comdata in its reasonable discretion. The Account will not be available to Customer until such security is accepted by Comdata in its sole discretion.
- (c) High Credit Risk. In the event that the Customer's Commercial and/or Consumer Credit Score, as reported by a credit reporting agency utilized at Comdata's discretion, is below Comdata's standard threshold for creditworthiness (this threshold is five hundred and twenty (520) for commercial credit scores and six hundred and sixty (660) for individual credit scores), or the Account incurs more than one late fee in any

12-month rolling period or is thirty (30) days or more delinquent in any 12-month rolling period, or makes a payment that is not honored by Customer's bank, Comdata shall deem the Customer to be "High Credit Risk Account" and reserves the right to change the Account's billing cycle, payment terms (days-to-pay), and credit limit upon notice to Customer. Comdata reserves the right to charge a High Credit Risk fee of up to ten cents per gallon for High Credit Risk Accounts. In the event an Account is deemed High Credit Risk Account by any of the criteria above, Comdata may also withhold any discounts earned until such time that Comdata, in its sole discretion, deems the Customer to no longer be High Credit Risk Account. Comdata may review each High Credit Risk Account at least once every three (3) months for changes in creditworthiness. The High Credit Risk decision is made solely by Comdata based on information provided by the credit reporting agency along with the Account's payment history. The credit reporting agency does not participate in the decision. Customer questions conceming their commercial and/or consumer credit scores should be directed to the applicable reporting agencies directly. - (d) Access & Unauthorized Use. Customer's representatives shall access the Account only as required to administer Customer's Card program and for no other purpose. Customer is responsible for all purchases and transactions made using Cards, Codes, Comcheks@, passwords or other security codes and procedures. If Customer or any of Customer's employees or agents gives a Card to any other person to use or otherwise authorize any person to use the Account, Customer will be responsible for all charges that such person makes on the Account, even if Customer did not anticipate or specifically approve the charges. Customer motify Comdata in writing if Customer wishes to revoke any permission Customer gave to another person to use the Account. Comdata then will take commercially reasonable efforts to comply with Customer's instructions to revoke that authority, which may include replacing the Card or Cards or changing the Account.
- (e) Notification of Unauthorized Use; Your Liability: Customer must notify Comdata immediately if Customer suspects or knows that any of Customer's Cards is lost or stolen and/or any Card has been used without authorization. Customer also must notify us immediately of any unauthorized use of, or access to, the Account or any passwords or other security codes or procedures used to access the Account or any Comdata's systems. Customer must provide the above notices to Comdata by calling Comdata at the toll free customer service line shown on the billing statement. Customer acknowledges and agrees that it is liable for unauthorized or fraudulent use of the Account or any Comdata's systems. Customer understands that it is the Customer's responsibility to select and apply transaction limitations on the Account/Card and monitor any suspicious and unauthorized activities on the Account. Customer understands that it is liable for unauthorized use of the Account and Cards to the fullest extent permitted by applicable law.

Customer agrees in any event that if at any time Customer has been issued ten (10) or more Cards at Customer's request, even if Customer does not use all such Cards, Customer will be liable for all unauthorized use of all Cards, and Customer waives any and all limitations of liability for unauthorized use of such Cards.

If Comdata issues fewer than ten (10) Cards to Customer, Customer's liability for unauthorized use of a Card will be limited to the lesser of (a) \$50 or (b) the amount of money, property, labor or services obtained by that unauthorized use. Customer will not be liable, however, for any unauthorized use that occurs after Comdata receives notices as required by this section of this Agreement. Customer also agrees to assist Comdata in determining the facts, circumstances, and other pertinent information related to any loss, theft, or possible unauthorized use of any Card or Account and to comply with such procedures as Comdata may reasonably require in connection with any investigation.

Notwithstanding the foregoing, Customer understands that Customer remains responsible for any and all misuse and unauthorized use of Cards by Customer's employees or agents. Customer is also liable for all use of a Card or the Account by an employee or agent following termination of employment or agency of such person, until Customer has notified Comdata to cancel the Card and Comdata has had a reasonable opportunity to cancel the Card.

(f) of Acts of <u>Justomers</u>. <u>Employees and Agents</u>. Customer agrees to hold Comdata harmless from any and all liability resulting from the acts of any employees or agents of Customer, which acts shall include but are not limited to negligent acts and willful misconduct of such persons, or from the breach by Customer of its obligations under this Agreement. For purposes hereof, any person who is given authorization by Customer to use Cards, Express Checks, codes, passwords or other security codes or procedures shall be deemed an employee or agent of Customer.

#### Other Products.

(a) Fuel Discount Program. Comdata may make one or more fuel discount programs available to Customer when Customer uses Cards to purchase fuel at participating merchants. Customer hereby enrolls in all such fuel discount programs made available by Comdata, and further agrees that such Comdata oroarams shall be the sole fuel discount Droarams used by Customer in association with the Cards. reserves the right to suspend, change or terminate any discount program at any time and in any manner in its sole discretion. Changes may include, among other things, changing the benefits, imposing additional restrictions, or terminating the program. In addition, Comdata reserves the right to remove the Account from the discount program in the event of any fraud, abuse, or late-payment.

#### (b) Fuel Tax Product.

- (i) The following terms apply if Customer enrolls in the fuel tax product offered by Comdata ("Fuel Tax Product(s)"). Using the Fuel Tax Product, Customer may generate mileage, fuel consumption, and fuel/road-use tax summary reports and has access to tools to assist the Customer in its review and preparation of fuel tax filings. Audit support services may be provided upon request and subject to additional fees and reimbursement of all travel and related expenses as may occur in connection with an audit. Audit Support services are limited to preparation and analysis of relevant records and facilitation of communications between Customer and the auditing jurisdiction. Customer is responsible for expenses incurred by Comdata on Customer's behalf.
- (ii) Customer agrees to provide access as required by Comdata to key Customer personnel to discuss Customer data and provide required background information. Customer is solely responsible for completeness of all tax retums, timely submission of tax retums to the taxing jurisdiction(s), and timely payment of all tax liabilities. Fuel tax liabilities are net covered by the Fuel Tax Product Fees, will not be billed to the Customer Card Account, or otherwise Invoiced to Customer: such taxes and/or fees must be paid directly by Customer to the appropriate agency within the applicable jurisdiction. Customer is responsible for: (1) collecting and maintaining all data records required by law. including, without limitation, all records required by IFTAi IRP or any taxing authority; (2) providing all data and records to Comdata in a timely manner (e.g., GPS tracking data, dispatch data, fuel purchase data, driver trip reports, third party providers, etc.); (3) accuracy and completeness of all data and records; (4) payment of jurisdiction fees, tax liabilities and/or other jurisdiction liabilities; (5) storing all supporting documents (including, but not limited to, trip reports and fuel receipts) in accordance with the retention requirements under applicable laws; (6) producing (in the event of an audit) documentation supporting the data provided to Comdata for fuel tax or registration purposes. Third Party License fees, setup of Data Extract Modules and integration software are separate and billed at cost. Any services outside the scope of this Agreement will be performed at a fee mutually agreed upon in writing by the parties. Comdata reserves the right to change the Fuel Tax Products at any time, including the modification of product features, layout or means for access.
- (c) National Tire Discount Program. Customer is being enrolled in Comdata's National Tire Discount Program, which allows Customer access to discounts made available directly through certain national tire retail brands ("Tire Retailers"). Customer hereby authorizes Comdata to share Customer information with Tire Retailers in connection with Customer's participation in the program. Customer acknowledges and agrees that the Tire Retailers, and not Comdata, are providing tires, discounts, and related products and services directly to Customer, and by purchasing from Tire Retailers, Customer is entering into a direct relationship with the Tire Retailers for such products and services. Purchases may be subject to additional terms, and account set-up requirements, of each Tire Retailer. Comdata reserves the right to suspend, change, or terminate the National Tire Discount Program at any time and in any manner in its sole discretion, including without limitation changing the available Tire Retailers, changing benefits, imposing restrictions, or removing the Account from the discount program in the event of fraud or abuse. COMDATA SHALL NOT BE LIABLE FOR THE ACTS OR OMISSIONS OF TIRE RETAILERS OR ANY FAILURE BY TIRE RETAILERS TO PERFORM, FOR WHATEVER REASON. COMDATA DOES NOT GUARANTY THE AVAILABILITY OF

ANY PRODUCTS FROM TIRE RETAILERS AND MAKES NO REPRESENTATIONS OR WARRANTIES, WHETHER EXPRESS OR IMPLIED, RELATED TO THE PRODUCTS AND SERVICES OFFERED BY TIRE RETAILERS, INCLUDING ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.

## 3. Fees and Payments Terms.

(a) Customer shall make payment to Comdata of the full amount due on its Account, plus all applicable fees set forth in the table below and as set forth elsewhere in this Agreement, in accordance with the billing cycle and payment terms established by Comdata,

and any failure to do so is a material breach of this Agreement. Account statements shall be available through Comdata's iConnectData self-service web portal. Customer must pay amounts due using a payment method accepted by Comdata; certain payment methods are subject to eligibility requirements and Comdata may specify a particular payment method for Customer. Customer may receive separate invoices by product, service or fee type. All payments made by Customer to Comdata will be applied against the outstanding amount due at the time the payment is received. Subject to applicable law, we will apply and allocate payments and credits among balances owed by Customer (whether for purchases, fees, late interest, or otherwise) in any order and manner determined by Comdata in its sole discretion. Customer agrees that Comdata has the unconditional right to exercise this discretion in a way that is most favorable or convenient to Comdata. Customer shall pay to Comdata a one-time account setup fee of \$50.00.

- (b) <u>Late Fees and Default Interest</u>. If Customer does not make full payment of the total amount due on the due date, then Customer shall pay a late payment fee equal to the greater of: (i) 5150 or (ii) 12.99% of the past due portion of the total amount due (excluding any previous late fees and any default interest charges). In no event will such late charge exceed the lesser of \$5,000 or the maximum amount permitted by applicable law. In addition, in the event the total amount due is not paid by the due date, then Comdata may assess a default interest charge at a rate equal to the wcckly average prime loan rate as published by the Federal Rcservc plus 4% per annum. The default interest is assessed on the total amount due (excluding any Inte fccs and any previous default interest charges) for the period of time such amount remains unpaid beyond the duc date. In no event will the default interest rate exceed the maxilnum rate permitted by applicable law.
- (c) <u>Changes to Fees and Payment Terms</u>. Comdata may add or modify fees or change payment terms by notifying Customer In writing at least fifteen (15) days before those changes take effect. In addition, Comdata may increase fees up to three percent (3%), without additional notice, for each year of the term after the Initial year as a cost of living adjustment.
- (d) Dis<u>puted Items</u>. Customer must notify Comdata of any disputed item on Customer's Comdata statement within sixty (60) days after the statement date or it will be deemed accepted by Customer. Unless required by law, Comdata is not responsible for any problem Customer may have with any goods or services charged on the Account. If Customer has a dispute with a merchant, Customer must pay Comdata and attempt to resolve the dispute with the merchant prior to sending the dispute to Comdata. Comdata is not responsible if any merchant refuses to honor Cards.
- (e) <u>Returned Payment; Collections</u>. Comdata reserves the right to charge a returned payment fee of twenty dollars (\$20) or the maximum amount permitted under applicable law, whichever is less. In the event that the Account is turned over to a collection agency or an attorney for collection of unpaid amounts or Comdata otherwise engages an attorney to enforce this Agreement, Customer agrees to pay all costs, fees and expenses of such agency or attomey, including, without limitation, court costs and out-of-pocket expenses.
- (f) Comdata Initiated ACH. Customer hereby requests and authorizes the bank identified in the Credit Application, ACH Authorization Form, or verbal ACH authorization to honor ACH debits and credits from Comdata to Customer's bank account. Customer represents, warrants and covenants that Customer's designated bank account for payments was established for business purposes and not for personal or household purposes. Customer agrees that, in respect to each such ACH credit or debit, the bank shall be under no obligation to furnish Customer with any special advice or notice in writing or otherwise of same. Customer agrees to be bound by NACHA Operating Rules. This authority is to remain in effect until revoked by Customer in writing to the bank and Comdata, and until the bank and Comdata actually receive such notice, Customer agrees that the bank shall be fully protected in honoring any such ACH credit or debit. Customer further agrees that if any ACH debit or credit shall be dishonored, the bank shall be under no liability whatsoever. Comdata shall notify Customer of the cutoff days for transactions to be included in the ACH debit. The ACH debit may not occur on this day but Customer's bank should debit Customer's account within 24—48 hours of the selected cutoff day. Customer shall provide prior notice to Comdata if Customer changes its bank and/or account information, and Customer shall, for a period of 48 hours from the time Comdata contacts Customer to confirm such change has been initiated, leave sufficient funds in Customer's existing account to cover any pending ACH debits. Customer shall notify its bank of this ACH authorization and ensure no security restrictions on its bank account prevent the ACH debits and credits.
- (g) <u>Lock Protection</u>. Lock Protection offers protection against Account locking due to Customer's failure to pay the total amount due by the due date. Should Customer fail to make such payment by the due date and the invoice becomes five days past due, Comdata will initiate an ACH debit for such amount. This payment will protect the Account from locking. Lock Protection does not change the payment terms, and

Customer remains responsible for making all payments on the due date. Late fees and default interest will still apply to late payments. If Comdata's Lock Protection ACH debit returns insufficient funds, Comdata may immediately lock the Account. Customer authorizes Comdata to make ACH debits and credits in connection with the Lock Protection program. Lock Protection will not be enabled until Customer sets up ACH payments. Comdata may require certain Accounts to participate in Lock Protection and will provide Customer notice if Customer's account is subject to such requirement.

4. <u>T minatign</u>. Customer or Comdata may at any time choose to terminate the Agreement and Customer's participation in the Program by providing the other at least thirty (30) days advance written notice of that decision to terminate. Customer may not terminate the Cards and retain access to the other Program products and services under this Agreement. Upon termination, Comdata shall have no requirement to make available any systems access or provide Customer with any information related to Customer's use of the Program, and Customer agrees to plan, and remain responsible, for any transition required for Customer to have timely fuel tax filings or satisfy other compliance requirements after termination. Notwithstanding the foregoing, Comdata may immediately suspend Customer's access to credit and/or Customer's use of the Account and Program (in whole or part) if payment on Customer's Account is past due. Comdata may immediately terminate this Agreement and the Account in the event of a suspected breach of this Agreement. Customer will pay all Fees when due and Davable under Customer's Account and/or the Aareement. whether or not Customer's Darticioation in the Program is

terminated. This Agreement may be terminated by Comdata if there has been no activity on Customer's account for a period of one year or longer.

- 5. Limitations of Liability. Comdata shall not be liable for any failure to perform due to acts of God, acts of government or regulatory bodies which significantly inhibit or prohibit the Program, wars, acts of terrorism, fires, floods, explosions, natural catastrophes, civil disturbances, strikes, riots, unusually severe weather (such as tornadoes), or failures or fluctuations in electrical power, heat, light, air conditioning, computer or telecommunications services or equipment or any other cause not within the reasonable control of Comdata. IN THE EVENT THAT CUSTOMER INCURS ANY LOSS, INJURY, DAMAGES, OR LIABILITY IN CONNECTION WITH THIS AGREEMENT, CUSTOMER SHALL NOTIFY COMDATA OF SUCH LOSS, INJURY, DAMAGES, OR LIABILITY IN WRITING WITHIN THIRTY (30) DAYS OF FIRST BECOMING AWARE OF SUCH LOSS, INJURY, DAMAGES OR LIABILITY. COMDATA'S SOLE LIABILITY, AND CUSTOMER'S SOLE REMEDY, FOR ANY ACTION OR FAILURE TO ACT OR ANY OTHER REASON UNDER THIS AGREEMENT SHALL BE LIMITED TO DIRECT MONEY DAMAGES IN AN AMOUNT NOT TO EXCEED THE TOTAL AMOUNT PAID BY CUSTOMER TO COMDATA WITH RESPECT TO THE DEFECTIVE SERVICE CAUSING THE DAMAGE DURING THE SIXTY (60) DAYS IMMEDIATELY PRECEDING NOTIFICATION. COMDATA SHALL HAVE NO LIABILITY FOR ANY LOSS, INJURY, DAMAGES OR LIABILITY THAT WAS NOT IDENTIFIED TO COMDATA IN WRITING WITHIN THIRTY (30) DAYS OF CUSTOMER'S FIRST BECOMING AWARE OF SUCH LOSS, INJURY, DAMAGES OR LIABILITY. IN NO EVENT SHALL COMDATA BE RESPONSIBLE FOR INDIRECT, CONSEQUENTIAL, SPECIAL, INCIDENTAL OR PUNITIVE DAMAGES, REGARDLESS OF WHETHER COMDATA WAS MADE AWARE OF THE POSSIBILITY OF SUCH DAMAGES.

NEITHER COMDATA NOR ANY PERSON ASSOCIATED WITH THE COMDATA MAKES ANY WARRANTY OR REPRESENTATION WITH RESPECT TO THE COMPLETENESS, SECURITY, RELIABILITY, QUALITY, ACCURACY OR AVAILABILITY OF THE PROGRAM OR ANY PRODUCTS OR SERVICES RELATED THERETO. IT IS EXPRESSLY AGREED AND UNDERSTOOD THAT COMDATA SHALL NOT BE LIABLE TO THE CUSTOMER NOR TO ANY THIRD PARTY FOR ANY LOSS OR DAMAGE (I) ARISING OUT OF FAILURE OF CUSTOMER TO MAINTAIN DATA RECORDS AS REQUIRED UNDER APPLICABLE STATE AND FEDERAL LAWS, RULES AND REGULATIONS, INCLUDING WITHOUT LIMITATION IFTA AND IRP REGULATIONS, (II) ARISING OUT OF ANY ACT OR OMISSION OF CUSTOMER (OR CUSTOMER'S EMPLOYEES, AGENTS, REPRESENTATIVES, OR VENDORS (E.G., GPS VENDOR)), INCLUDING WITHOUT LIMITATION THE PROVISION OF ACCURATE INFORMATION, DATA AND/OR RECORDS TO COMPLETE ANY FORMS, TAX RETURNS OR OTHER DOCUMENTS OR TO PROCESS ANY PAYMENT DUE HEREUNDER, OR (III) OTHERWISE ARISING IN CONNECTION WITH THE PROGRAM. COMDATA MAKES NO REPRESENTATIONS OR WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY, NONINFRINGEMENT, OR FITNESS FOR A PARTICULAR PURPOSE.
- (b) CUSTOMER SHALL INDEMNIFY AND HOLD COMDATA HARMLESS OF AND FROM ANY AND ALL LIABILITIES RESULTING FROM ANY ACT OR OMISSION BY ANY OWNER, EMPLOYEE, OR AGENT OF CUSTOMER, INCLUDING BUT NOT LIMITED TO, ACTS OF COMMISSION OR OMISSION DEEMED TO BE WILLFUL OR NEGLIGENT.
- 7. Confidentiality. Customer agrees and covenants that it shall not, during the performance of this Agreement or at any time after the termination or expiration hereof, use or disclose to any third party other than during the proper performance of their duties hereunder, the confidential and proprietary information of Comdata ("Confidential Information"), including but not limited to the rates, terms, and conditions of this Agreement, technical information; transaction information; or any of the procedures, practices or confidential dealings of the other party hereto. The foregoing shall not apply to a disclosure required by law provided if a subpoena or court order compels disclosure, Customer will (unless lawfully prohibited) immediately notify Comdata and cooperate to limit disclosure to the extent required by law. Customer acknowledges and agrees that the application software developed. utilized and maintained by Comdata, the internal hardware utilized by Comdata, the internal operating procedures employed by Comdata, technical information, such as file record layouts, and transaction information, including without limitation Comdata card numbers and data gathered at the point-of-sale by Comdata, are Confidential Information and the exclusive and proprietary property of Comdata.
- 8. Right of Setoff. Comdata shall have the right to setoff and apply any amounts owing by Comdata to Customer against any amounts owing from Customer to Comdata pursuant to any Agreement between Comdata and Customer or any amounts in the possession of or under the control of Comdata.
- 9. Monitoring and/or Recording Communication. Customer understands and agrees that Comdata may in its discretion, but is not obligated to, monitor and/or record any telephone calls by Customer or its employees and/or agents without any further notice for quality control purposes and for its own protection. Comdata may also monitor, record, and/or make a record of any other communications between Customer or its employees and/or agents and Comdata without any further notice, and Comdata may use the resulting information for internal purposes or as may be required by applicable law. Customer hereby consents to Comdata's monitoring and/or recording of any telephone calls and communications with Customer or its employees and/or agents. Customer acknowledges and understands Comdata may not record all telephone calls or communications, and Comdata does not guarantee that recordings of any particular telephone calls or communications will be retained or be capable of being retrieved.
- 10. Provider of Services. "Comdata" means Comdata Inc., a Delaware corporation and one or more of its subsidiaries designated by it to provide the applicable services hereunder, including, without limitation, Comdata Network, Inc. of California, the licensed money transmitter in the State of Califomia, to provide licensed money transmission services to customers with a billing address in Califomia, and Comdata TN, Inc., a licensed money transmitter/check seller in other states, to provide such services to customers with billing addresses in those states. Customer hereby agrees that for Accounts with a billing address in the State of California, all Comcheks that are used are issued by Comdata Network, Inc. of California regardless of the name of the issuer printed on the Comchek paper instrument.
- 11. Government Regulation. To help the government fight the funding of terrorism and money laundering activities, federal law requires Comdata to obtain, verify, and record information that identifies Customer (and any guarantor or co-maker) as part of initial and on-going customer review processes. Therefore, Comdata may, at Comdata's option, require Customer to provide various identifying information that will allow Comdata to properly identify Customer, which may include but not be limited to name, address, taxpayer identification number, and other information. Customer represents and covenants that Customer (a) is not currently and shall not become subject to any law, regulation or list of any government agency (including, without limitation, the U.S. Office of Foreign Asset Control list) that prohibits Comdata from making any advance or extension of credit to Customer or from otherwise conducting business with Customer, and (b) Customer shall provide to Comdata, when requested, documentary and other evidence of Customer's identity or the identity of any person to whom Customer provides a Card, so that Comdata may comply with any applicable law or regulation or Comdata's AML Policy.
- 12. <u>Customer Compliance</u>. Customer shall be bound by and comply with all applicable laws and regulations ("applicable law") and all payment network rules, guidelines, requirements, and prohibitions ("network rules") regarding Customer's use of the Account and Card(s). Customer shall permit Comdata to reasonably investigate or audit Customer's compliance with applicable law and network rules regarding

customers use of the Account ana card(s).

13. Modifications to this Agreement. Customer may not modify this Agreement. In addition to Comdata's rights under Sections 1, 2 and 3, Comdata may change or replace any or all terms of this Agreement at any time, including, without limitation, in the event of any future changes to applicable law, by sending Customer notice of any such change at least thirty (30) days prior to the effective date of the change,

unless a shorter notice period is required by applicable law. Retention or use of the Account after the effective date of any such change will constitute acceptance of the new terms.

- 14. Notices\* Customer Contact. Except as set forth herein, all "notices" must be in writing. In addition to the foregoing, any notice or communication from Comdata to Customer may be provided by email or other electronic means. Customer agrees to keep the primary email address associated with the Account up to date at all times. Any notices sent by Comdata to such email address associated with Customer's Account shall be deemed properly delivered. Customer consents to Comdata's (including Comdata's affiliates') contacting Customer and Customer's employees concerning Comdata's and its affiliates' products and services. Customer hereby consents that the means of such contact may include phone calls and/or SMS messages (including through the use of autodialer technology) to Customer and Customer's employees mobile or home phone numbers, to the extent such are provided to Comdata and its affiliates'.
- 15. Governing Law; Waiver of Jury Trial; Binding Arbitration.
- (a) This Agreement shall be exclusively governed by the laws of the State of Tennessee without regard to the choice of law rules of such state.
- (b) You or Comdata may, without the other's consent, elect mandatory, binding arbitration for any claim, dispute, or controversy between or among such parties arising from or in any way relating to the Cards or Account, a prior related account, or the relationship of such parties, including without limitation claims regarding the application, enforceability, or interpretation of this Agreement and this arbitration provision, and no matter what legal theory such claims are based on or what remedy (damages, or injunctive or declaratory relief) such claims seek (a "Claim"). The party filing for arbitration must choose one of the following arbitration firms and follow its rules and procedures for initiating (including paying the filing fee) and pursuing arbitration before a single neutral arbitrator: American Arbitration Association, National Arbitration Forum, or JAMS. All other fees will be allocated as provided by the rules of the arbitration firm and applicable law.

<u>Can I assert or participate In a class action?</u> To accommodate the right to arbitrate, you agree that you will neither assert, nor participate in, a class action or other representative action or proceeding related to this Agreement, the Account, the Cards or any other aspect of your relationship with Comdata. Claims must be brought in the name of an individual person or entity and must proceed on an individual (non-class, non-representative) basis.

Who can be a pady2 The arbitrator will not award relief for or against anyone who is not a party. If you or we'require arbitration of a Claim, neither you, we, nor any other person may pursue the Claim in arbitration as a class action, private attorney general action or other representative action, nor may such Claim be pursued on your or our behalf in any litigation in any court. Claims, including assigned Claims, of two or more persons may not be joined or consolidated in the same arbitration. However, applicants. co-applicants, authorized users on a single account and/or related accounts, or corporate affiliates are here considered as one person.

What Claims are subject to arbitration? All Claims relating to your Cards or Account, a prior related account, or our relationship are subject to arbitration, including Claims regarding the application, enforceability, or interpretation of this Agreement and this arbitration provision. All Claims are subject to arbitration, no matter what legal theory they are based on or what remedy (damages, or injunctive or declaratory relief) they seek. This includes Claims based on contract, tort (including intentional tort), fraud, agency, your or our negligence, statutory or regulatory provisions, or any other sources of law; Claims made as counterclaims, cross-claims, third-party claims, interpleaders or otherwise; and Claims made independently or with other claims. A party who initiates a proceeding in court may elect arbitration with respect to any Claim advanced in that proceeding by any other party. Claims and remedies sought as part of a class action, private attorney general or other representative action are subject to arbitration on an individual (non-class, non-representative) basis, and the arbitrator may award relief only on an individual (non-class, non-representative) basis.

Whose Claims are subject to arbitration? Not only ours and yours, but also Claims made by or against anyone connected with us or you or claiming through us or you, such as a co-applicant or authorized user of your account, an employee, agent, representative, affiliated company, predecessor or successor, heir, assignee, or trustee in bankruptcy are subject to arbitration. What time frame applies to Claims subject (o arbitration? Claims arising in the past, present, or future, including Claims arising before the opening of your account, are subject to arbitration.

<u>Broadest interpretation</u>. Any questions about whether Claims are subject to arbitration shall be resolved by interpreting this arbitration provision in the broadest way the law will allow it to be enforced. This arbitration provision is governed by the Federal Arbitration Act (the "FAA").

What about Claims filed in Small Claims Court? Claims filed in a small claims court are not subject to arbitration, so long as the matter remains in such court and advances only an individual (non-class, non-representative) Claim.

How does paw Initiate arbitration? The party filing an arbitration must choose one of the following three arbitration firms and follow its rules and procedures for initiating and pursuing an arbitration: American Arbitration Association, JAMS, and National Arbitration Forum. Whatprocedures and law are applicable In arbitration? A single, neutral arbitrator will resolve Claims. The arbitrator will be either a lawyer with at least ten years of experience or a retired or former judge, selected in accordance with the rules of the arbitration firm. The arbitration will follow procedures and rules of the arbitration firm in effect on the date the arbitration is filed unless those procedures and rules are inconsistent with this Agreement, in which case this Agreement will prevail. Those procedures and rules may limit the discovery available to you or us. The arbitrator will take reasonable steps to protect your account information and other confidential information if requested to do so by you or us. The arbitrator will apply applicable substantive law consistent with the FAA and applicable statutes of limitations. will honor claims of privilege recognized at law,

and will have the power to award to a party any damages or other relief provided for under applicable law. You or we may choose to have a hearing and be represented by counsel. The arbitrator will make any award in writing and, if requested by you or us, will provide a brief statement of the reasons for the award. An award in arbitration shall determine the rights and obligations between the named parties only, and only in respect of the Claims in arbitration, and shall not have any bearing on the rights and obligations of any other person, or on the resolution of any other dispute.

<u>Who</u> pays? Whoever files the arbitration pays the initial filing fee. If we file, we pay; if you file, you pay, unless you get a fee waiver under the applicable rules of the arbitration firm. If you have paid the initial filing fee and you prevail, we will reimburse you for that fee. All fees will be allocated as provided by the rules of the arbitration firm and applicable law. However, we will advance or reimburse your fees if the arbitration firm or arbitrator determines there is good reason for requiring us to do so, or if you ask us and we determine there is good reason for doing so. Each party will bear the expense of that party's attorneys, experts, and witnesses, and other expenses, regardless of which party prevails, but a party may recover any or all expenses from another party if the arbitrator, applying applicable law dptprminag

When is an arbitration award final? The arbitrator's award is final and binding on the parties unless a party appeals it in writing to the arbitration firm within fifteen days of notice of the award. The appeal must request a new arbitration before a panel of three neutral arbitrators designated by the same arbitration firm. The panel will consider all factual and legal issues anew, follow the same rules that

apply to a proceeding using a single arbitrator, and make decisions based on the vote of the majority. Costs will be allocated in the same way they are allocated for arbitration before a single arbitrator. An award by a panel is final and binding on the parties after fifteen days has passed. A final and binding award is subject to judicial review and enforcement as provided by the FAA or other applicable law.

<u>Survival and Severability of Terms</u>. This arbitration provision shall survive: (i) termination or changes in the Agreement, the account, or the relationship between you and us concerning the account; (ii) the bankruptcy of any party; and (iii) any transfer, sale or assignment of your account, or any amounts owed on your account, to any other person or entity. If any portion of this arbitration provision is deemed invalid or unenforceable, the remaining portions shall nevertheless remain in force. Any different agreement regarding arbitration must be agreed to in writing.

- 16. No Assignment' Complete Agreement. Customer may not transfer or assign this Agreement without the prior written consent of Comdata. This Agreement and the materials referenced above, and Customer's accepted Credit Application, contain the complete agreement between Customer and Comdata for Customer's participation in the Program, and may be amended only (a) in writing signed by the parties or (b) by Comdata in accordance with Sections 1, 2, 3 or 13, or (c) by Customer's acceptance of additional or substitute terms delivered to Customer by Comdata via phone, website, email, text, or such other means as may be elected by Comdata. Upon Comdata's reasonable request, Customer agrees to promptly complete and deliver such further documents as necessary or appropriate in connection with this Agreement.
- Miscellaneous. (a) None of the provisions of this Agreement is intended to create nor shall be deemed or construed to create any relationship between the parties hereto other than that of independent entities contracting with each other hereunder solely for the purpose of effecting the provisions of this Agreement. Neither of the parties hereto, nor any of their respective employees, shall be construed to be the employer of the other. Customer and Comdata agree that Comdata is only providing services under this Agreement as an independent contractor. (b) Customer shall be bound by and comply with all applicable laws and regulations ("applicable law") and all payment network rules, guidelines, requirements, and prohibitions ("network rules") regarding Customer's use of the Account and Card(s). Customer shall permit Comdata to reasonably investigate or audit Customer's compliance with applicable law and network rules regarding Customer's use of the Account and Card(s). (c) Any provision of this Agreement that by its nature is intended to survive termination of this Agreement shall so survive and shall remain enforceable after such termination. (d) The section and other headings contained in this Agreement are for reference purposes only and shall not affect the meaning or interpretation of this Agreement. (e) In case one or more of the provisions contained in this Agreement or any application thereof shall be invalid, illegal, or unenforceable in any respect, the validity, legality. and enforceability of the remaining provisions contained herein and any other application thereof shall not in any way be affected or impaired hereby. (f) Comdata's failure to insist upon strict compliance with any of the terms or conditions of this Agreement shall not be deemed a waiver of such term or condition, nor shall waiver or relinquishment of any right or power hereunder at any time be deemed a subsequent waiver or relinquishment of such right or power.
- 18. <u>Electronic Signatures</u>. Customer and Comdata agree that the electronic signatures used in connection with this Agreement are intended to authenticate this writing and to have the same force and effect as a manual signature.

BY CLICKING "SUBMIT APPLICATION' IN THE MYFLEET ONLINE APPLICATION, GUARANTOR HEREBY SIGNS AND ACCEPTS THE TERMS OF THE GUARANTY. IF GUARANTOR DOES NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO <u>NOT</u> CLICK "SUBMIT

In order to induce Comdata to extend credit to XXXXX (the "Debtor") and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Guarantor hereby covenants and agrees as follows:

The Guarantor hereby guarantees to Comdata the full and prompt payment and performance of all obligations, whether now existing or hereafter arising, of Debtor to Comdata, including, but not limited to, the payment of all sums due by Debtor to Comdata, whether now owing or hereafter arising, and the performance of all obligations under any and all instruments, documents, and/or agreements now existing or hereafter arising that evidence. secure or otherwise relate to any sums or obligations due or owing by Debtor to Comdata (all the foregoing collectively hereinafter referred to as the "Guaranteed Obligations"). For the purposes of this Guaranty, the "Guaranteed Obligations" shall include the payment of all sums due by, and the performance of all obligations of, any assignee of an instrument, document, and/or agreement between Debtor and Comdata, but shall not include any such obligations between Debtor and Comdata that are incurred after the effective date of Comdata's release of this Guaranty.

This Guaranty is an irrevocable, continuing, absolute and unconditional guaranty and shall remain in full force and effect until released in writing by Comdata. This Guaranty is a guaranty of payment and performance and not of collection.

At any time after the Debtor has failed to pay or perform any of the Guaranteed Obligations or is otherwise in default with respect to any of the Guaranteed Obligations, Comdata may demand payment and performance from the Guaranter of any or all of the Guaranteed Obligations whether pursuant to acceleration or otherwise.

The Guarantor waives notice of acceptance hereof, presentment, demand, protest, or notice of protest. Guarantor consents that Comdata may, without affecting the obligation hereunder, grant the Debtor an extension of time or other indulgence with respect to any of the Guaranteed Obligations. Without limiting the foregoing, the Guarantor hereby agrees and consents that Comdata may, without affecting the Guarantors' liability hereunder, accept other guaranties as to any of the Guaranteed Obligations; surrender, release, exchange, or consent to the modification of, all or any part of the collateral for any of the Guaranteed Obligations or accept other collateral from anyone; extend the time for payment or performance of, or grant renewals of, any of the Guaranteed Obligations or any part thereof, either for the same, an increased, or reduced amount; accelerate the time of payment or performance thereof; make additional advances or extensions of credit to Debtor; release or fail to set off any deposit, account or credit of the Debtor; release any person or entity liable for the payment of any of the Guaranteed Obligations; accept additional makers, endorsers, or guarantors as to any of the Guaranteed Obligations or change the rate(s) of interest thereon; take or omit to take any action pursuant to the provisions of any document, instrument or agreement evidencing, securing or otherwise relating to any of the Guaranteed Obligations or any renewal or extension thereof; waive or modify any of the provisions of any of such documents, instruments or agreements; or grant other indulgences to any party thereto, all from time to time, before or after maturity thereof, all with or without further notice to or assent by the Guarantor without affecting or releasing the liability of the Guarantor, and the Guarantor hereby expressly waives notice of nonpayment, notice of sale or application of collateral or advertisement of such sale, and any and all other notices in connection with any of the Guaranteed Obligations, any collateral securing the Guaranteed Obligations, this Guaranty and any obligation or liability covered hereunder. Guarantor further waives any defenses based on suretyship or impairment of collateral.

The Guarantor's obligations and liability shall not be affected in any manner whatsoever by any change, loss, or deterioration in value of any collateral or of the financial condition of the Debtor or the Guarantor, whether due to incorrect estimates of such value or financial condition, failure to protect or insure. or any other reason.
